



Terms & Conditions:

Website Maintenance:

- It is the client's responsibility to have the data supplied in a good and sorted professional condition, to allow Dream D-Zigns to upload and maintain your website on a Monthly or Weekly bases as agreed between you as client and us.
- Dream D-Zigns can make a monthly or weekly maintenance agreement with you as client or we use pay per hour structure.
- After maintenance has been done on your website payment must be paid within 24ours or the changes will be restored the original stage.
- Monthly maintenance will be due for payment on the first of each calendar month, if the maintenance has not been paid by the 5th of the month you will be charged an penalty of R90. You will be held responsible for the monthly maintenance amount irrespective weather website maintenance was required or not. Maintenance agreement is based on a monthly payment and you as client have the responsibility to supply Dream D-Zigns in time with your changes to be updated onto your website.
- This Maintenance contract does not include any website designing changes and is strictly for the data uploading and monthly changes, no structure changes. Structure changes will be an additional charge on your invoice.
- R&D T/A Dream D-Zigns will not be supplying you with a VAT Invoice as we are not registered for VAT.

Website Hosting:

- No Illegal content is allowed on your website and you as client should be responsible for what you use your website for. Dream D-Zigns will not be held responsible for any cases opened against you for illegal data or information.
- You as client agreed to pay us on a Monthly base as agreed on by you as client and Dream D-Zigns.
- Your payment should be paid on the first of each calendar month.
- If you are more than 7 days behind with your payment your website will be deactivated till payment was is visible in our accounts. You will also be charged an penalty of R90.

- New website design will only be launched and made available to public when final payment is received.
- Payment to be done Via Internet Banking only.

- No work will be done till your deposit of 50% of the designing cost is visible in our bank account.
- If you as client agreed that R&D T/A Dream D-Zigns must design you as client a website you will be charged for the work and design, if you decide that you are not going to use our design anymore after the work has started or halfway in progress you will be charged for the full amount of work done per hour and the Design cost as per our email agreement or if we had other written designing cost between the client and us.

- After the final product has been completed and presented to you as client for approval we will no longer be responsible for any structure changes, all changes required after original design will be charged to you as client.
- R&D T/A Dream D-Zigns do only frontline designing on this stage till further notice.
- We do not do Java Designing on this stage.
